## 2024 Spring Production Contract

The Spring Production is a time and financial commitment. I understand that I must carefully read the terms of this agreement and by signing this contract, the student and parent both agree to adhere to this agreement.

- $\quad$ Students will be on time for classes and rehearsals and ready to rehearse at specified times. Multiple tardiness or absences may result in removal from the Production. Rehearsal listed times are the times the student must be on the stage or at the studio ready to rehearse.
- $\quad$ Student/Parent will be responsible to know all necessary rehearsal dates and times, as well as production and costume information. All information is accessible on the school's website, newsletters and emails.
- Student/parent understands that a $\$ 225$ production fee is required for students who choose to participate in the Spring Production. The fee is paid in two installments: $\$ 100$ of this fee is due by the end of October and guarantees you two orchestra seat tickets to the show. The remaining $\$ 125$ is due by April 8, 2024. You may choose to solicit up to two business ads for the production program to reduce the 2nd production fee; one ad (regardless of ad size) will deduct $\$ 50$ from the remaining $\$ 125$ due in April. Two business ads will deduct $\$ 100$ from the $\$ 125$, leaving only the $\$ 25$ fee for the professional video link. Families with more than one child enrolled need to pay for the video link only once and may deduct $\$ 25.00$ from the additional child's production fee.
- Production tickets will be available online to purchase. I understand that the ticket website address will be provided at a later date. A voucher code will be provided to each family to redeem the two tickets included in the required production fee. Ticket prices are $\$ 25$ and $\$ 30$ not including the online service charge.
- All rehearsals are mandatory. By signing this contract, I understand that I am agreeing and committing to attend all rehearsals including the mandatory in-studio rehearsals on May $17^{\text {th }}$ and $18^{\text {th }}$ (tentative dates) and the mandatory stage dress rehearsals on May $30^{\text {th }}$ and $31^{\text {st }}$ along with the production on June $1^{\text {st. }}$
- $\quad$ Student may be removed from a dance or from the entire production if missing more than three rehearsals or three classes after March 2023.
- Student/Parent understands that there is a costume fee of $\$ 95$ per costume. By signing this agreement, and choosing to participate in the production, I understand that I am accepting responsibility to pay the costume fee for the purchase of the necessary costume by the due date of October 30, 2023. I understand that a Costume Order Form needs to be completed (one for each class dance a student is participating in) to provide the appropriate size to be ordered. A costume will not be ordered without both the Costume Order Form completed and turned into the office and the Costume Fee paid in full by October 30, 2023.
- If Student is invited to participate in an additional dance, I understand that an additional costume fee or studio costume rental fee may be required.
- If invited for the classical portion of the production, I understand that extra rehearsals, costumes and class fees will be required. I understand that should I accept the invitation to the Classical, that I am required to attend the Friday evening class from 5-7 p.m. starting in February, 2024. Additional fees include the Classical Deposit of $\$ 150$, due by October 30, 2023, and the Classical Rehearsal fee of $\$ 150$, due by January 22, 2024. The Classical Deposit may not cover the entire cost of the Classical Costume and additional fee(s) may be required. Students participating in the classical shall not miss more than three rehearsals and/or three classes, starting in February, 2024.
- Any student that chooses to participate in the Spring Production, tentatively scheduled for April 13, 2024, is required to participate in the Student Presentation at St. John Vianney Family Life Center. Tickets will be available to purchase for $\$ 20$ cash or check only at the office during office hours. More details will follow once information is available. By signing the contract, you acknowledge and accept the responsibility to commit and participate in the Presentation.
- Costumes will need alterations and student/parent is responsible for completing those alterations prior to Picture Day, regardless of participation in picture day. If no Picture Day is held, all alterations are required to be completed by April 28, 2024.
- $\quad$ Specific roles, class and dance placements, and solos are at the sole discretion of the Executive Director and teachers.
- Parents, family members and friends are not allowed backstage or in the theatre during dress rehearsals. Males are not allowed backstage or in the dressing rooms at any time unless participating in the performance or part of the technical crew. Designated assistants will be backstage to help the dancers prepare for the show.
- For the privacy of the students, cell phones are strictly prohibited backstage and in the dressing rooms during all dress rehearsals as well as the show. This rule applies to all show participants.
- All school fees must be paid in full on or before April 30, 2024. If the account is open, I understand my dancer(s) will not be allowed to participate in the Spring Production.
